Participant Release

In consideration of the services and activities to be provided or made available to me by London Enterprises Limited operating as Sonora Resort, and its directors, officers, employees, agents, independent contractors, guides and all other persons or entities acting on its behalf (collectively **"Sonora"**), I hereby acknowledge and agree, on behalf of myself and my heirs, successors, assigns and legal representatives, as follows:

I acknowledge that any of the activities I undertake during my stay at Sonora, while within or outside of the physical premises of Sonora and including transport by way of boat, air or land to or from Sonora, involve known and unanticipated hazards and risks that could result in injury, death or damage to myself, to property or to third parties; examples of activities I may undertake or participate in may include, but are not limited to: fishing, kayaking, boating (including use of Zodiacs), rafting, archery, horseback riding, hiking, bear, whale and other wildlife watching and other eco-tourism activities, as well as my consumption of any alcohol (collectively the "**Activities**"). The risks to which I may be exposed to during any Activities may include, but are not limited to: slipping and falling; water hazards; drowning; exposure to temperature and weather extremes; equipment failure; injury from wildlife encounters, including firearm discharge; collision or accidents, including those which involve any use by guest of resort vehicles; injury due to walking on slippery or unstable surfaces; being struck by bows or dislodged or unsecured equipment or objects; the forces of nature, including lightning and rapid weather changes; and medical conditions brought on in part or in whole by my own physical condition and the physical exertion associated with any Activities I participate in (collectively the "**Risks**").

I understand that such Risks cannot be fully eliminated without jeopardizing the essential qualities of the Activities. I further understand that Sonora, including the guides it has provided for my benefit, have difficult jobs to perform. They seek safety, but are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions or the applicable equipment. They may give inadequate warnings or instructions or the equipment being used might malfunction.

I expressly agree to accept and assume all of the Risks inherent in or related to all Activities, facilities, equipment or services I participate in, use or receive the benefit of during my stay at Sonora. My participation in all Activities and my use or receipt of all services, facilities and equipment is purely voluntary and I elect to participate, use or receive same in spite of the Risks and I agree to bear all the costs of any resulting injury or damage. I am also willing to assume the risk of any medical or physical condition I may have, whether disclosed or undisclosed to Sonora.

I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Sonora from and against any and all claims, demands, costs, fees (including legal fees on a solicitor and own client basis), losses, expenses, liability or causes of action of any kind, whether known or unknown, by myself or any other person or entity (collectively the "**Claims**"), which may arise now or in the future and are in any way connected with my participation in any Activities or my use or receipt of Sonora's equipment, facilities or services, and all the Risks associated therewith, including but not limited to any Claims which may be based on any negligent acts or omissions of Sonora.

I acknowledge that Sonora uses cameras to monitor activity at Sonora. Cameras are only located within public areas of Sonora and any recordings shall only be used for safety, insurance, legal or internal business operations of Sonora; under no circumstances shall any recordings containing any images of Sonora guests be released or distributed to any third party, expect pursuant to insurance or legal requirements.

This Release is governed by the laws of British Columbia, Canada. In the event any term of this Release is found to be unenforceable for any reason, the remaining terms of this Release shall continue unaffected and in full force to the greatest extent permitted by law.
